Notice of the Change in Company Name

Relo Holdings, Inc. (“the Company”) announces that its Board of Directors resolved to change the company name at a meeting held on May 12, 2016. The change is pending approval of a partial revision of the Company’s Articles of Incorporation at the 49th Ordinary Shareholders’ Meeting, scheduled to be held on June 23, 2016. The details are as follows.

1. Change in Company Name

(1) Reason for the change

The Company introduced the holding company structure in July, 2001, and by splitting up and empowering each business domain, it has accelerated its decision making and built a governance system that allows its subsidiaries to focus on their own businesses. Based on the policy of “giving opportunities to potential leaders,” it has cultivated a number of business leaders by having them manage the subsidiaries of the Company.

Currently, the Company has broadened its horizons with 45 consolidated subsidiaries and over 1,500 employees. The initiatives for building up future management have also produced results.

This year the Company celebrates the 50th anniversary of its founding. It believes that changing the corporate name will elevate team spirit and bring everyone together, foster greater cooperation between companies, and accelerate the cross sales of each service.

With this change, the Company and the entire group will continue to develop business domains and increase the corporate value, while at same time work to strengthen its brand power in order to become a “world-class relocation company.”
